# National Center for Immunization and Respiratory Diseases (NCIRD) communications resource roundup

This communication applies to the Medicaid programs for Simply Healthcare Plans, Inc. (Simply) and Clear Health Alliance (CHA) as well as the Florida Healthy Kids (FHK) program.

Since the onset of the COVID-19 pandemic, a significant drop in well visits has resulted in vaccination delays. Many patients may have cancelled or missed appointments and essential vaccines, putting them at risk for dangerous diseases. Simply has prioritized immunization compliance efforts to address concerns related to secondary outbreaks of vaccine-preventable illnesses.

The NCIRD has developed materials to remind parents that well-child visits and vaccinations are essential. These include:

### Impact of COVID-19 pandemic on pediatric vaccination

The CDC assessed the impact of the COVID-19 pandemic on pediatric vaccination in the United States. The study, published in the May 8 issue of the Morbidity and Mortality Weekly Report (MMWR), found notable reductions in the number of vaccine doses ordered through the Vaccines for Children (VFC) program. A second study published in the May 18 issue of the MMWR found that vaccination coverage declined in all milestone age cohorts, except for birth-dose hepatitis B coverage. Up-to-date series coverage for each age cohort was lower for Medicaid-enrolled children than for other children.
