



## Healthy Behaviors Rewards Programs for Florida Healthy Kids members

In accordance with the Florida Healthy Kids Corporation (FHKC) directive, as of January 1, 2020, the plan must establish and maintain programs to encourage healthy behaviors. Simply Healthcare Plans, Inc. has developed six programs for asthma, maternity, smoking cessation, weight loss, alcohol or substance use recovery, and well-child visits. The program goals and provider roles are shown in the table below. Additional details about each individual program in its entirety are available.

Weight management  Asthma management	<ul> <li>Assist plan members with weight management</li> <li>Offer medically directed program</li> <li>Reward success</li> <li>Enhance plan's clinical program</li> <li>Asthma action plan for self-management</li> <li>Promote medication</li> </ul>	<ul> <li>Identify and refer to the program</li> <li>Develop a plan of care with the member</li> <li>Attest/sign members' weight management forms as proof of goals achieved</li> <li>Identify and refer to the program</li> <li>Asthma visit to PCP or pulmonologist</li> <li>Pharmacy data for medication compliance</li> <li>Submit visit and vaccination claims</li> </ul>
Maternal child	adherence	<ul> <li>Identify and refer pregnant members to the program</li> <li>Prenatal and postpartum visits</li> <li>Well-child visits (0 to 15 months)</li> <li>Submit visit claims so members will receive valuable gift card rewards</li> </ul>

Well-child visits (5 to 18 years)	<ul> <li>Encourage children's well-child exams per Bright Futures guidelines</li> <li>Encourage annual preventive dental visit</li> <li>Encourage compliance with recommended immunizations and lead screening</li> </ul>	<ul> <li>Complete well-child health checkups, immunizations and lead screening</li> <li>Refer members for annual preventive dental appointment</li> <li>Submit visit claims so members will receive valuable gift card rewards</li> </ul>
