Description of long-term care services

Adult day health care offers social events and a safe place for members to go while family caregivers are busy. Adult day care centers have health, social, and support services. Most centers are open during work hours. Some have evening, night, and weekend hours. These centers don't have 24-hour care. They may offer healthy meals for members during meal times.

Adult family care home (AFCH) is a private setting that has housing, meals, and personal care services for older persons and disabled adults not able to live alone. An AFCH is run by licensed AFCH providers who live with the members they help. Also, an AFCH is limited to five members at most. An AFCH is meant to be a less costly choice for members who don't need 24-hour nursing care.

To live in an AFCH, a member must meet certain residency measures, decided by Florida regulations and by the provider's admission rules. An AFCH helps members manage personal care services and medication. **Room and board costs are not included.**

Assisted living has personal care services in a home-like setting with a great deal of freedom. An assisted living facility (ALF) can have many residents. Personal care and some nursing care are available to meet each member's needs. Care may include:

- Adult companion services.
- Attendant services.
- Homemaker services.
- Medication management.
- Personal care services.
- Social and recreational programs.

Room and board costs are not included.

Community-based long-term care (LTC) providers help people with disabilities with daily life. Programs and services may include:

- Adult companion care.
- Adult day health care.
- Assistive care services.
- Assisted living.
- Attendant care.
- Behavioral management.
- Caregiver training.
- Care coordination/case management.
- Home accessibility adaptation.
- Home-delivered meals.
- Homemaker services.
- Hospice.
- Intermittent and skilled nursing.
- Medical equipment and supplies
- Medication administration.
- Medication management.
- Nutritional assessment/risk reduction services.
- Nursing facility services.
- Occupational, physical, respiratory, and speech therapies.
- Personal care.
- Personal emergency response systems (PERS).
- Respite care.
- Transportation (nonemergency).

Community-based LTC services have what members may need to improve their freedom.

Hospice is a type of care for members and their families when a disease no longer responds to treatment and a cure isn't expected. Hospice care doesn't extend life nor hurry death. The goal is to help improve the member's last days through comfort and dignity. Hospice care handles the member's:

- Medical care.
- Pain management.
- Emotional, social, and spiritual needs, as well as the needs of family or friends.

Hospice care is offered through a team approach. Bereavement and counseling are also available to families before and after a member's death.

Nursing facilities have nursing, personal, and custodial care for members who are ill or not physically able to care for themselves. Nursing facilities are for members who need 24/7 nursing care and have major health problems making day-to-day life hard to handle. Members are required to pay for their patient responsibility, as decided by the Department of Children and Family Services.

Descripción de servicios de cuidado a largo plazo

Cuidado de la salud de día para adultos ofrece eventos sociales y un lugar seguro al cual puedan ir los afiliados cuando el personal de cuidados de la familia esté ocupado. Los centros de cuidados de día para adultos tienen servicios de salud, sociales, y de apoyo. La mayoría de los centros están abiertos durante horas laborales. Algunos tienen horarios de tarde, noche, y fines de semana. Estos centros no tienen atención las 24 horas. Pueden ofrecer alimentos saludables para los afiliados durante las horas de comida.

Hogar para cuidado familiar de adultos (AFCH) es un entorno privado que tiene servicios de alojamiento, comidas, y cuidado personal para ancianos y adultos discapacitados que no pueden vivir solos. Un AFCH es manejado por proveedores autorizados de AFCH que viven con los afiliados a los que ayudan. Además, un AFCH tiene un límite de cinco afiliados como máximo. Un AFCH tiene la intención de ser una opción menos costosa para los afiliados que no necesitan cuidado de enfermería las 24 horas del día.

Para vivir en un AFCH, el afiliado debe satisfacer ciertas medidas de residencia, decididas por las regulaciones de Florida y por las reglas de admisión del proveedor. Un AFCH ayuda a los afiliados a manejar los servicios de cuidado personal y los medicamentos. **No se incluyen los costos de alojamiento y comidas.**

Vida asistida tiene servicios de cuidado personal en un entorno igual al hogar con una gran cantidad de libertad. Un centro de vida asistida (ALF) puede tener muchos residentes. Hay disponible cuidado personal y cierto cuidado de enfermería para satisfacer las necesidades de cada afiliado. El cuidado puede incluir:

- Servicios de acompañante para adultos.
- Cuidado de asistente.
- Servicios de tareas domésticas.
- Administración de medicamentos.
- Servicios de cuidado personal.
- Programas sociales y recreativos.

No se incluyen los costos de alojamiento y comidas.

Los proveedores de cuidado a largo plazo (LTC) basado en la comunidad ayudan con las actividades de la vida diaria a las personas que tienen discapacidades. Los programas y servicios pueden incluir:

- Cuidado de acompañante para adultos.
- Cuidado de la salud de día para adultos.
- Servicios de cuidado asistido.
- Vida asistida.
- Cuidado de asistente.
- Manejo del comportamiento.
- Entrenamiento del personal de cuidados.
- Coordinación de los cuidados/administración de casos.
- Adaptación de accesibilidad al hogar.
- Comidas entregadas en el hogar.
- Servicios de tareas domésticas.
- Hospicio.
- Enfermería especializada e intermitente.
- Equipos y suministros médicos.
- Administración de medicamentos.
- Manejo de medicamentos.
- Servicios de evaluación nutricional/reducción de riesgos.
- Servicios en centros de enfermería.
- Terapia ocupacional, física, respiratoria, y del habla.
- Cuidado personal.
- Sistemas personales de respuesta de emergencia (PERS).
- Cuidado de relevo.
- Transporte (no de emergencia).

Los servicios de LTC basados en la comunidad tienen lo que pueden necesitar los afiliados para mejorar su libertad.

Hospicio es un tipo de cuidado para afiliados y sus familias cuando una enfermedad ya no responde al tratamiento y no se espera una cura. El cuidado de hospicio no alarga la vida ni apresura la muerte. La meta es mejorar los últimos días del afiliado mediante comodidad y dignidad. El cuidado de hospicio maneja estos aspectos del afiliado:

- Cuidado médico.
- Control del dolor.
- Necesidades emocionales, sociales, y espirituales, al igual que las necesidades de la familia o los amigos.

El cuidado de hospicio se ofrece a través de un enfoque de equipo. También hay disponibles servicios para el duelo y consejería para las familias antes y después del deceso del afiliado.

Los centros de enfermería tienen cuidado de enfermería, personal y asistencial para afiliados que estén enfermos o que no puedan cuidarse físicamente por sí mismos. Los centros de enfermería son para afiliados que necesitan cuidado de enfermería las 24 horas del día, los siete días de la semana y tengan problemas de salud importantes, haciendo que la vida diaria sea difícil de manejar. Se requiere que los afiliados paguen su responsabilidad del paciente tal como lo decida el Department of Children and Family Services.
